## 1. Introduction

This Cookies Policy (“Policy”) sets out the manner in which Oval Ltd (“Oval”, “the Company”, “we”, “us”, or “our”) uses cookies and similar tracking technologies on its website and online platforms (“Website”). The Company is licensed and regulated by the Financial Services Authority (“FSA”) of Seychelles as a Securities Dealer under License Number SD221.

The purpose of this Policy is to provide clear, transparent, and comprehensive information regarding how cookies operate on our Website, the categories of cookies we use, the purposes for which they are used, and the rights available to you as a visitor or client (“user”). This Policy forms part of and should be read together with our Privacy Policy.

By accessing or using our Website, you acknowledge that you have been informed of the use of cookies and that you consent to the practices described herein, unless you have adjusted your browser settings to refuse cookies.

## 2. Definition of Cookies

Cookies are small text files that are placed on your browser or device when you access a website. These files store information about your interaction with the Website and enable the site to recognise your device upon subsequent visits.

Cookies typically contain a unique identifier, the domain from which they originate, and information relating to your browsing activity. Cookies do not normally collect information that directly identifies you as an individual. However, certain information collected through cookies may be associated with your personal data when combined with other information you provide to us.

Cookies are widely used to ensure websites function efficiently, enhance user experience, maintain security, and enable website operators to analyse performance and usage patterns.

### 3. Purpose of Using Cookies

Oval uses cookies strictly in accordance with applicable laws, regulatory guidance, and industry best practices. Cookies may be used for the following purposes:

1. **To ensure technical functionality:** Certain cookies are required for the Website to operate correctly, enable secure login sessions, and facilitate navigation.
2. **To enhance user experience:** Cookies may store preferences such as language, region, and interface settings to provide a customised browsing experience.
3. **To improve Website performance:** Analytical cookies enable us to assess how users interact with the Website, allowing us to improve page structure, content, and functionality.
4. **To support security and fraud prevention:** Cookies help us identify irregular or potentially malicious activities and maintain the integrity of user sessions.
5. **To facilitate marketing and attribution:** Cookies assist in measuring the effectiveness of digital campaigns, tracking referral sources, and attributing conversions to authorised affiliates or partners.
6. **To comply with operational and regulatory requirements:** Cookies may contribute to audit trails, system security, and reporting obligations required by financial regulators.

### 4. Categories of Cookies Used by Oval

To provide clarity and consistency with international regulatory standards and industry practice, Oval categorises cookies into the following types:

#### 4.1. Necessary Cookies

These cookies are essential for the Website to function correctly. They enable secure login, form submissions, navigation, and access to protected sections of the platform. Because they are critical for basic site operation, they cannot be switched off through browser settings without impairing functionality.

#### 4.2. Functional (Preference) Cookies



Functional cookies enable the Website to remember the choices you make, such as your language, region, or preferred interface settings. These cookies allow us to provide you with an enhanced, personalised browsing experience each time you return.

#### 4.3. **Analytical and Statistics Cookies**

Analytical cookies help us understand how visitors interact with our Website. They collect aggregated, anonymous data about page views, session duration, device types, navigation patterns, and traffic sources. This information allows us to improve Website structure, optimise performance, and enhance user engagement. Examples include analytics tools such as Google Analytics or Yandex Metrica.

#### 4.4. **Marketing Cookies**

Marketing cookies track your browsing activity across our Website and, in some cases, across third-party sites. They enable us to deliver more relevant advertisements, limit the repetition of ads, and measure the effectiveness of marketing campaigns. These cookies may be placed by advertising networks with our authorisation.

#### 4.5. **Affiliate and Attribution Cookies**

Oval uses attribution cookies to track partner referrals, assign unique identifiers, and ensure proper crediting of leads or conversions to affiliates or introducing brokers. These cookies remain anonymous and are used only to support accurate tracking and partner reconciliation.

#### 4.6. **Third-Party Cookies**

Some cookies on our Website are placed by third parties such as analytics providers, social media services, advertising partners, and integrated platforms such as live chat tools or embedded media services. These cookies may recognise whether you are logged into external platforms (e.g., Google, YouTube, Facebook) and may record interactions with features connected to those services. Oval does not control third-party cookies directly and recommends reviewing the respective cookie policies of those providers.

### 5. **Duration of Cookies**

Cookies may be classified as:

- **Session cookies**, which remain active only for the duration of your browsing session and are automatically deleted when you close your browser; or
- **Persistent cookies**, which remain stored on your device for a predetermined period or until manually deleted.

Both types may be used depending on the purpose of the cookie.

## 6. Managing and Blocking Cookies

You have the right to manage, restrict, or delete cookies through your browser settings. Most browsers allow you to:

- block all cookies
- block certain types of cookies
- delete existing cookies
- receive alerts when a cookie is placed
